## Who we are

**Alfred Studio App** is owned and operated by minic studio SRL, a limited liability company in Romania under minic studio SRL whos registered address is Odorheiu Secuiesc, Pietroasa street 18/11, Harghita county. Our VAT number is RO29545189 and company nr. is J19/14/2012.

## Information we collect and how we use your data

### Public account info

- At the moment we don't have community platform, accordingly we don't share any information you gave.
- You do not have to use your real name on Alfred Studio, you may use a pseudonym. You can also change your display name and any of your content at any time.

### Private account info

- We collect your email address at signup. We use your email address to send you communication essential to providing service, including registration confirmation and password reset email. We also use your email address to provide you with information about the service or notify you about product updates and community activity. You may opt out of these non-essential emails by sending us an e-mail to [support@alfredstudio.app](mailto:support@alfredstudio.app).
- We collect a password at signup. We recommend that you use a unique password for every online service you use.

### Information about user behavior with Cookies

Alfred Studio uses cookies and similar web browser technologies, like localStorage, to help make it easier to use our service. For example, we use them to help keep you logged in and remember your preferences.

We also use cookies to gather information about user behavior on Alfred Studio. For example, we may measure how often you use one of Alfred Studio's features. We use this information to help plan development of new features, and to tailor direct marketing to how you use Alfred Studio. ## Information we do not collect

The Services are available only to individuals who have the capacity to form legally binding contracts under the law applicable to our Terms of Service. Alfred Studio does not target its offerings toward, and does not knowingly collect any personal information from users under 13 years of age, or 16 years of age if residing in the EU/EEA. If we become aware that we have unknowingly collected personal information from a child under the age of 13 (or 16 in EU/EEA) we will delete that information.

## Your choices and obligations
